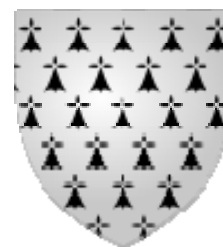
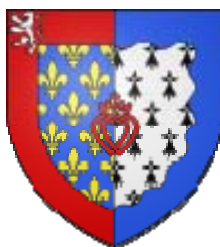

On 12th June 2008, politicians and experts representing the agricultural sector from a number of European regions exchanged information and debated the most challenging issues related to the Common Agricultural Policy. During the conference “What does the Health Check mean for the Regions and what comes next?” the debate centred on the impact of the legislative proposal of the Health Check and future challenges of the CAP.
