Apostolos TZTZIKOSTAS

Apostolos Tzitzikostas was born on September 2, 1978. He studied Government and International Relations at Georgetown University, in Washington DC. After graduating in 2000, he had his first working experience at the Office of the President of the Committee on Foreign Affairs of the United States Congress. In 2002 he obtained a master's degree on European Public Policy and Economics from the University College of London. Following his studies, he created his own company on the field of production, processing and standardization of dairy products, based on organic standards.

In 2007, he has been elected Member of the Greek Parliament with the Nea Demokratia Party (EPP) in the First District of Thessaloniki. In the regional elections of November 2010 he was elected Vice-Governor of the region of Central Macedonia and Head of the Metropolitan Area of Thessaloniki. On the Regional Elections of May 2014 he was elected Governor of the Region of Central Macedonia, and on the Regional Elections of May 2019 was re-elected Governor of the Region of Central Macedonia. In November 2019 he has been elected President of the Association of Greek Regions.

Since 2015 he is a Member of the European Committee of the Regions. In July 2017, he has been elected Head of the Greek Delegation and Vice-President of the European Committee of the Regions. He fluently speaks English and French and his articles are regularly being published in Greek and foreign newspapers and magazines.

Eric-Mark Huitema is the Director General of the European Automobile Manufacturers' Association (ACEA), a position he has held since October 2019. Before joining IBM, Mr Huitema worked in the IT sector, including for Liberty Global's broadband internet start-up Chello Benelux (which he co-founded and led as Global Vice President), EDS International and Philips Electronics.

A Dutch national, Eric-Mark Huitema studied technical chemistry at Delft University of Technology and business and sales administration at INSEAD.

He is currently member of the COTER Commission, CIVEX Commission, Enlargement Day, EPP Group, CoRAI.

He was rapporteur on topics of high European interest: the opinion on Enlargement Strategy and candidate countries 2007-2008 (2008), the opinion on the implementation of the European Neighbourhood Policy, in particular the Eastern Partnership Initiative: modernisation, reforms and administrative capacity of the local and regional authorities of the Republic of Moldova (2010), the opinion on trans-European networks of communication (2012) and the opinion on the respective guidelines (2013), the opinion on Digital Single Market: Mid-term review (2018).

He speaks English, French, Italian and Spanish.

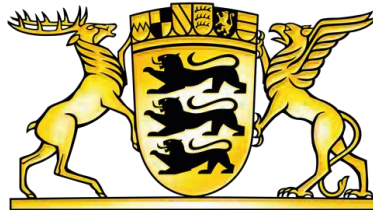

Patrick RAPP

Dr. Patrick Rapp was born on 28th January 1969 in Stuttgart. After completing his school-leaving examination in Riedlingen/Donau and doing alternative national service at the German Red Cross District Association in Sigmaringen, he studied forestry science at the Albrecht Ludwig University of Freiburg, concluding his studies in 1997 with the degree of graduate forester. Mr. Rapp subsequently completed a doctorate at the Institute for Forestry Policy of the Albert Ludwig University.

After working as a management assistant to the executive board in the food industry and as a personnel manager in the timber industry, Dr. Rapp has been first elected to the State Parliament of Baden-Württemberg in 2011. After his re-election in 2016, he became chairman of the Rural Areas and Consumer Protection Working Group and has been the speaker on tourism policies for the CDU state parliamentary group since 2011. In 2021 he has been again elected to the State Parliament of Baden-Württemberg.

Dr. Rapp is a member of the Tourism Advisory Board of Baden-Württemberg, a member of the advisory board of the Albert Ludwig University of Freiburg, and is honorary president of the Confederation of German Brass Instrument Associations in Staufen.

On May 12th, 2021 Dr. Patrick Rapp was appointed State Secretary in the Ministry of Economic Affairs, Labour and Tourism of the Federal State of Baden-Württemberg
